The «Fulbright Foreign Student Program» offers students with Swiss citizenship and English proficiency funding to pursue studies at the master's or Ph.D. level. This can be done at any recognized institution of higher education in the United States in any field of study except medicine, dentistry, and veterinary medicine. The grants are 4 to 10 months in length and not renewable. They are to be used toward the cost of tuition and other academic expenses. In general, a grant for one academic year is about \$20'000. #### • European Funding Guide

→ EU-wide platform for student financing (scholarships, grants, information on student loans, etc.); also, internships. Registration required (free of charges).

#### Fundraiso.ch

→ Swiss platform specialized in fundraising; directory with foundations, funds and sponsors. Access possible without registration, but then limited to 20 entries. It is therefore recommended to register; the purchase of a chargeable subscription is not necessary for this. The use of the basic version (contains all Swiss, but no foreign foundations) is free of charge, although not very user-friendly.

#### lefa – International Scholarships & Financial Aid

→ The platform is aimed at students, including doctoral students, who are looking for international scholarships or student loans. The "Loans" section is more suitable for US Citizens/US Permanent Residents or people who want to study in the US; the "Scholarships" section contains a lot of useful information on grants and scholarships for international students of all disciplines and degrees as well as all countries of origin and destination. Access with registration, the basic version is free of charge.

#### Research Professional

→ Database with international funding instruments, grants, fellowships, etc.; free access for researchers with UZH account (incl. doctoral students).

#### Research.swiss

→ Platform of SERI and Swissnex with national and international funding instruments/programmes; more suitable for more advanced researchers (postdoc level and above).

#### • StiftungSchweiz

→ Similar to Fundraiso.ch (see above). The use of the basic search is free of charge and possible without registration, although not very user-friendly. Attention: registration is apparently not possible without a chargeable subscription. Be careful not to subscribe by accident!

#### • Stiftungssuche des Bundesverbandes Deutscher Stiftungen

→ Digital version of the German Foundation Directory; the free basic version contains only a few search options and only foundations with websites, but this is usually quite sufficient. Attention: subscriptions are quite expensive. Be careful not to subscribe by accident!
